#### **SECTION 6. Accidental release measures.**

## 6.1. Personal precautions, protective equipment and emergency procedures.

FOR LIQUID PRODUCTS:

Block the leakage if there is no hazard.

FOR SOLID PRODUCTS:

If there are no contraindications, spray powder with water to prevent the formation of dust. Avoid breathing vapours/mists/gases.

#### 8.2. Exposure controls.

#### 10.1. Reactivity.

There are no particular risks of reaction with other substances in normal conditions of use.

#### 10.2. Chemical stability.
